Sub: Extension of Timelines for Submission of various categories of Applications under SARAS 7.0 Portal for the Affiliation Session 2027-28 – Reg.

Reference is invited to this Office Circular No. 07/2026 dated 26.02.2026 regarding submission of various categories of applications under the SARAS 7.0 Portal for Affiliation for the Session 2027-28.

The Board, after due consideration, has decided to extend the last date for submission of online applications up to 30.09.2026 for Affiliation for the Session 2027-28 across all categories of applications.

Furthermore, the timelines already expired during the period in which the SARAS Portal remained non-functional, has also been extended, in respect of applications submitted under SARAS 7.0. In all such cases, the applicant school is allowed an additional period of thirty (30) days from the date of issue of this notification for submission of "compliance after grant". A period of fifteen (15) days for submission of "compliance after deficiency at Part A level" is also allowed from the date of issue of this notification.

Accordingly, the timelines prescribed for submission of consent by the members of the Inspection Committee, selection and finalization of the date(s) of inspection, conduct of inspection, submission of the Inspection Committee Report, and all other consequential time-bound activities shall also stand extended correspondingly.
