WHEREAS we have long cherished desire for constituting a trust in the best interests of human development especially the social, educational, economic and cultural improvement and upliftment of the society.

AND WHEREAS we hope that the said interests and objects can be attained by devoting the undermentioned Trust among and its income:

NOW THIS DEED Witnesseth, and we do hereby declare as follows:-

- I. **NAME OF TRUST** : The name of Trust shall be **BLOSSOM EDUCATIONAL TRUST**. The short name of '**BLOSSOM TRUST**' may be used in all its transactions.

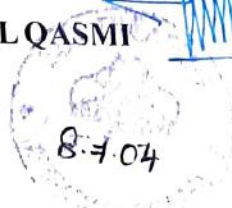
II. **OFFICE:** The Head Office of the Trust shall be situated at Koovalloor. But it can be shifted to any other place in Kerala. Sub offices may be opened at other places if the Board deem it necessary for the well administration of the Trust.

III. AIMS AND PURPOSES OF THE TRUST:

- a. To establish and conduct Educational Institutions like Medical colleges, Engineering Colleges, Residential and Public Schools, Orphanages, Shelter Homes for the poor, Arts and Science Colleges, Technical Institutions, Libraries, Hostels, Hospitals, Paramedical Institutions, and other Social, Educational and charitable Institutions.
- b. To establish a fund to promote higher medical and technical education among the people of our country by giving Scholarships, Stiphends, Loans, Grants etc. to the poor and deserving students.
- c. To help and assist in all possible manners those people living below the poverty line irrespective of Caste, Religion or Community and to do all things to improve their standard of living in all walks of life.
- d. To promote and foster religious harmony between all religious communities in India and to co-operate with them sincerely to keep the same.

To strive to help, assist and conduct marriages of poor Widows and other poor women of the weaker sections of the society and to assist and build houses for the homeless poor and to do such other charitable acts and things, for the burial of dead-bodies irrespective of Caste, Religion or Community.
- f. To create and establish Craft and Industrial Training Centres, Industries and business concerns with a view to provide work to solve unemployment.
- g. And to do all such other acts, deeds and things to help, assist to all social and national institutions as the Board decides.

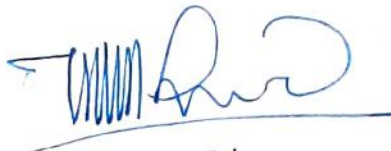
V. POWERS OF THE BOARD

- a. The Board shall appoint the necessary staff, employees and other officials for the functioning of the Trust and shall have power to decide all matters relating to such appointments and other relevant factors in connection with the same.
- b. The Board shall approve an annual budget for ensuing financial year categorising the heads of income and expenditure. But the Board is at liberty to expand the unspent amount for one category to the other according to importance, urgency and circumstances. The financial year shall be April to March.
- c. The Board shall have power to accept the trusteeship, the managements of another trusts or endowments and such Trusts, or endowments shall

be administered under the provisions of this deed in addition to any other agreeable directions made by the donor of such trusts or endowments.

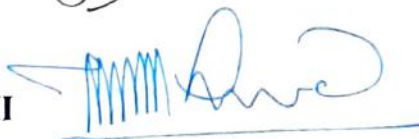
- d. The Board shall have powers to acquire, accept or receive all endowments, gifts, grants, donations and any other contributions of any sort, movable or immovable made to this Trust, by individuals, groups, families, organizations, or association whether incorporated or not, or by any government, State, Central or Foreign and all such Gifts, Grants, donations and contributions would be considered as part of this trust properties and their managements, income and expenditure shall be unconditionally carried on as per provisions of this deed.
- e. The Board shall have the power to sell the movable and immovable properties of this Trust or any part thereof in case of unavoidable necessity and circumstances or for purchasing other more beneficial properties. The Board also shall have the power to Pawn, pledge or mortgage the Trust properties to borrow and raise funds and loans whenever found necessary and such Pawn, pledge, mortgage or sale shall not be valid unless passed by the Board by two third majority of the members of the Board and all such transactions and purchases shall be made in the name of the Chairman and Managing Trustee jointly.
- f. The Board shall deposit the funds of the Trust in such Bank or Banks as decided by the Board in the name of the Trust. The Chairman & Managing Trustee jointly shall have the power to negotiate and operate such bank accounts by issuing signed Cheques, bills and drawing amounts.

VI. DURATION OF THE BOARD:

The Board which we have constituted and appointed hereby will be a permanent Board of Trustees and any vacancy in the Board occasioned by death, resignation, dismissal or otherwise shall be duly filled up by nominating members from outside by a resolution passed by the existing board with a two-third majority.

VII. ENLARGEMENT OF THE BOARD:

According to the circumstances and necessity of occasion as felt by the Board is empowered and authorized to enlarge its strength by nominating members from outside as it feels necessary.

VIII. OFFICE BEARERS OF THE BOARD:

The board shall have a Chairman and a Managing Trustee. (hereafter be known as Managing Director). They will hold office for a period of five years. After the expiry of this period another Chairman and Managing Director shall be elected from the existing board of trustees. Mr. Meethalakath Mahmood Trustee Number one, Sayed Muhammed Al-Qasmi Trustee number two are here by appointed by as the Chairman and Managing Trustee respectively for the first period of five years. They shall be eligible for re-election after the expiry of their period.

IX. FUNCTIONS OF THE CHAIRMAN:

The Chairman will preside over the Board Meetings supervise the functioning of the Board, and give necessary directions to the proper administration of the Board. He shall the power to take any disciplinary action against the officials and employees of the trust and trust on the institutions subject to the approval of the Board. He shall also join with the Managing Trustee to operate the Bank accounts. The Chairman is also empowered to delegate his powers to Managing Trustee, or trustees or other persons to get things done as his representative for specific purposes.

X. MANAGING TRUSTEE: (MANAGING DIRECTOR).

The Managing Trustee shall perform the day-to-day administrations and management of the Trust including the preparation of the annual budget. He must be in charge of keeping the books of accounts and writing the receipts and expenditure of the Trust and shall convene the meetings of the Board according to the instruction of the Chairman. He shall represent the Board in all actions, civil, criminal or revenue and in all offices of the Government, Central, State and Foreign, including sales tax and Income Tax Offices and Offices of the Municipalities or Panchayat and other office and before all appellate authorities of such offices.

XI. MEETINGS AND SITTING ALLOWANCES:

Ordinary meetings of the Board may be convened as and when found necessary by issuing three days notices to the members of the Board. The attending members are eligible to get sitting allowances, bata, honorarium and travelling expenses in such manners and from such period as and when decided by the Board.

XII. QUORUM AND MAJORITY:

The Quorum of the Board shall be five in number or one-third of the trustees of the Board whichever is less and all the decisions of the Board shall be in writing and the majority of the members present. The majority decision of the Board shall not be questioned by any member of the Board. But the Board will have its discretion to review its own decisions. If any meeting is adjourned for want of quorum and if convened within one month, decisions may be validly passed without required quorum.

XIII. DISCIPLINARY ACTION:

Any Trustee or Trustees whose behavior are found detrimental to the interest of the Trust may be proceeded against by suspension and dismissal by a resolution approved by the Board by majority votes.

XIV. BYELAWS:

To facilitate the smooth administration of this Trust, the Board by two third majority frame byelaws which shall not be repugnant to any article of this deed or against the objects and purpose of this Trust.

XV. AUDITING:

The accounts of the Board will be audited by Chartered Accountants or other auditors including the Board members appointed by the Board.

XVI. IRREVOCABILITY:

This Trust is an irrevocable Trust and neither we our descendants, nor legal heirs have any right or authority to revoke it. But it can be joined or amalgamated with other Trusts having the same objects with a resolution passed by the Board with two third majority decision of the Board members.

XVII. TRANSFER OF THE TRUST AMOUNT:

We have today handed over on this 12th day of July 2004, the sum of Rupees Six thousand to the Trustees of this board towards the Trust amount of this Trust which they acknowledge and agree to hold in trust with the subject to the powers, provisions and declarations contained in this Trust Deed.

XVIII. ACT APPLICABLE:

This Trust is to be governed by the provisions of Indian Trust Act (Act 11 of 1882)

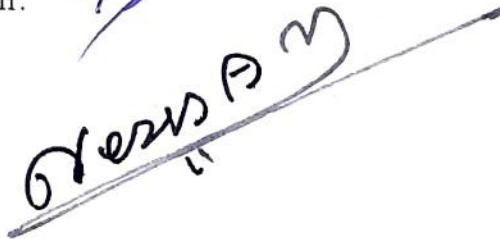

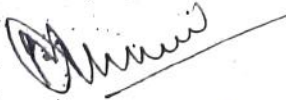
