Sub.: Request for Extension of Provisional Affiliation Beyond 31/03/ 2019 – reg.

Sir/Madam,

This has reference to the Inspection report received (Inspection held on **23.07.2018**) bearing registration **EX-03326-1819** dated **30.06.2017** on the above subject.

In this regard, the following deficiencies / requirements have been observed during the scrutiny of the Inspection Report. The School is required to submit the specific compliance of the following deficiencies / requirements within 30 days.

1. The reply of Show Cause Notice No. CBSE/Aff./930585/2019/1480448 dated 02.05.2019 has not submitted by the school till date. The school is required to submit the reply of Show Cause Notice.
2. The school is required to submit Recognition Certificate for class 1<sup>st</sup> to 8<sup>th</sup> issued by the State Education Department. If, recognition certificate has not obtained by the school earlier, then, the school is directed to apply for the same immediately and submit it to CBSE office, within a period of one year on issuance of this grant letter.
3. The school is required to submit Fire Safety Certificate issued by concerned Govt. authority (i.e. Fire Safety Department of the State).
4. The School is required to submit renewed copy of Building Safety Certificate issued by concerned Government Authority (i.e. Govt. Engineer).
5. The school is required to appoint Special Educator as per rule 13(11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015.
6. The school is required to submit a certificate from the concerned DEO/BEO, that the school is paying salary to its employees as per State Govt. norms.
7. The school is required to maintain the reserve fund as per strength of the school in the joint names of Principal of the school and Managing Trustee/Member of the society/Trust/Company running the school as per provisions of Affiliation Bye-Laws of the Board and copy of FDR may be furnished to the Board for record purpose.

However Extension of affiliation from 01.04.2019 for a period of 05 years will be subject to the specific compliance of the discrepancies communicated by the School within 30 days failing which a penalty of Rs.20,000/- per month will be levied on the school and the process of withdrawal of affiliation of the School may also be initiated.
