IV. Aims and Objects:-


The objects for which the Trust is established are:







- (g) To establish, acquire, maintain and manage facilities such as offices, residential accommodation, hostels, library and information technology centres.
- (h) To undertake joint ventures with Corporate bodies/Institutions under terms and conditions approved by the Board of Trustees.
- (i) To acquire by way of purchase of gift, or to take on lease or hire or otherwise temporarily or on permanent basis, any movable or immovable property for the purpose of the Trust.
- (j) To sell, assign, mortgage, hypothecate, lease, exchange transfer or otherwise deal with all or any property movable or immovable of the Trust in the way it may find necessary and to take necessary action for proper maintenance of any such building, movable or immovable property.
- (k) To donate suitable sums and to provide scholarships and endowments to other institutions and individuals with a view to encourage and promote the objectives of the Trust.

- (n) To appoint faculty members, research scholars, consultants, experts and other staff in accordance with the rules of the Trust.









(e) The members of the Board of Trustees are not barred from accepting any remuneration for their services as found reasonable by the committee for their services

(f) The Board of Trustees is the executive authority of the Trust and is responsible for formulation and implementation of policies and the day to day management of the affairs of the Trust.

(g) The Board of Trustees meeting shall be held at least once in every three months. (1) The Secretary shall convene the meetings and record the minutes. (2) There shall be 3 days notice unless waived by all members of the Board. (3) The quorum for the meeting shall be 51% with fraction rounded to the next higher number. (4)The meeting shall be presided over by the Chairman. (5) Decision shall be taken by show of hands or by secret ballot by the members present and each member present shall have only one vote. (6) Decision shall also be taken by the circulation if all members agree to the same.







- b) To solicit funds, receive donations, grants, subsidies, scholarships etc. of any kind, towards cropus or otherwise with permanent obligations or otherwise, whether in cash or kind.
- c) To invest the funds of the Trust in any manner they deem fit consistent with the objects of the trust and in the interest of the Trust.
- d) To incur all kinds of capital and revenue expenditure which will help in attaining any or all of the objects of the Trust, such as acquiring land, constructing building and equipping and travelling expenses of personnel etc.
- e) To borrow any amount either pledging the assets of the Trust or otherwise, from individuals, banks, financial institutions or other institutions, with or without interest for attaining any of the objects of the Trust
- f) To acquire, alter, extend, demolish any of it's assets, movable or immovable and to dispose off the same whenever found necessary in the best interest of the objects of the Trust.
- g) To chalk out plans to augment funds to achieve the main objects of the trust and to carry out the same.
- h) To frame such rules and regulations as are necessary, but not inconsistent with the provisions of this deed, for the proper and efficient administration of the Trust and institutions/establishments belonging to or managed by the Trust.
- i) To review and make decision on the annual account presented by the Secretary in the annual general body meeting.
- j) No trustee can sell or transfer his rights in the trust to any other person or persons other than the trust.
- k) Trustees who act against the terms and conditions between the trustees or the provision of the trust deed can expel from the trust with a 2/3 (two-third) majority of persons present and voted in the meeting of the executive Committee









held for the same. The right in the trust, if any entitled by such expelled member must be given to him/her with in one year from the date of such expulsion.







- f) Whenever felt necessary, Secretary of the Executive Committee or as and when requested by 1/3 members of the Board of Trustees, also convene the meeting of the Executive Committee.
- g) The notice of the meeting of the Executive Committee shall be served at least 3 days before the meeting unless waived by 75% of the members eligible to get the notice.
- h) The quorum of the meeting shall be 51% with fraction rounded to the next higher number.
- i) The Secretary of Board of Trustees shall convene the Annual General Meeting of the Board of Trustees before September 30th to transact the following business.
- (1) To review the activities and to discuss the audited statements of account for the previous financial year ended with 31st March
  - (2) To suggest future plan of action and ways and means to achieve the same.
  - (3) To consider other matters referred to by the Executive Committee of Trustees.

VIII. Custodian of the Trust:-

- a) All the properties of the Trust shall vest in the name of the Board of Trustees.
- b) The Secretary of the Executive Committee shall sue and be sued for and behalf of the Trust provided that the Executive Committee of Trustees shall have the power to authorize any of it's other members to represent the Trust in any legal or other proceedings under special circumstances.

ix. Powers and duties of the Executive Committee:

Subjected to the general control of the Board of Trustees, the Executive Committee shall have specific powers and duties mentioned below:

- a) To work, manage, control and supervise the affairs/management of the properties belonging to the trust and develop them.
- b) To enter into any contract or agreement for and on behalf of the Trust for any of the purpose concerning the routine activities/affairs of the Trust, which are beneficial to the interest of the Trust.
- c) To appear and act for and on behalf of the Trust in all legal proceedings before any competent authority.
- d) To appoint and constitute advocate or other attorneys, whenever necessary personnel in the service of the Trust, fix their remuneration and service conditions and give them training if necessary, and if circumstances warrant, to take disciplinary action against them including suspension or dismissal.
- f) To take loans or borrow money as decided by the board of Trustees and to execute promissory notes, bonds or similar documents and to discharge the same by repayments.
- g) To gather funds towards corpus or otherwise, for the Trust by way of donations or otherwise, from any person or institutions, either in cash or in kind for the purpose of the Trust.
- h) To spend the income earned or the income of the future for any or all of the objects of the Trust, either directly or by contributing to other genuine institutions to be spent for the purposes of the Trust.










- i) To accumulate the income, if necessary, for attaining the objects of the Trust in future and to set apart the whole or part of the income for the corpus of the Trust fund for any of the objects of the Trust.
- j) To exercise and perform such powers and duties as the Board of Trustees may from time to time determine or assign or authorise the Executive Committee to do so.
- k) To do any/all acts and deeds and things necessary for the efficient management and administration of the trust and the properties of the Trust.
- x) Bank Accounts:- Bank Accounts shall be opened in the name of Trust or in the name of its activities with any Treasury. Post Office or Banking Institutions or Commercial Banks, as and when found necessary by the Executive Committee of Trust and such account shall be operated jointly by the Chairman, Secretary and Treasurer or otherwise decided by the Board of Trustees from time to time.

Any of two among the President, Secretary and Treasurer are empowered to sign cheques for withdrawing any amount from the Bank.

xi) Accounts:- The accounts of the Trust shall be closed on 31st March every year and it shall be audited by an auditor appointed by the Board of Trustees. The chairman shall see that the audited statement with explanations of the Executive Committee shall be submitted to the Board within 30th September every year or within the time extended by them.

xii) Amendments:-

a) This is an irrevocable Trust. For Administrative Convenience, in the years to come, any provision in this deed except the object clause No. IV and Saving Clause No. XIV and this clause may be amended, annulled substituted by the Board of Trustees, either suo-moto or by the recommendation of the Executive Committee. It is further provided that after getting any recognition under the

b) All starting or closing of any organisation or enterprise under this Trust or linked to this Trust should be done with the written agreement of trustees of their authorised representative.










xiii) Dissolution: In the event of the Trust becoming impossible to function in accordance with the provision of the Trust deed and if the Board of Trustees unanimously decided to wind up the Trust, the assets of the Trust after discharging of all its debts and liabilities shall be dealt with, according to law and with the approval of the Trustees, by transferring to other registered charitable institutions with objects more or less similar to this, or it shall vest with the Government.

xiv) Saving Clause:-

a) This is an Educational Charitable Trust and it is expressly declared that any part of the income or funds, of the institution shall be opened to all irrespective of caste, creed and community.
