described in the Schedule hereunder which we have acquired by virtue of Sale Deed of No. 708 of 1933 of the Sub Registry Office of Malappuram, in trust and trust for them to the Trustees appointed herein below with and subject to the rights and powers herein after expressly provided.

3. AIMS OF THE TRUST.

The purposes for which the income of this Trust shall be used are the following:-

(a) To help, assist, support or otherwise accelerate or facilitate the teachings of Islam and other activities of Islamic Institutions and extend fiscal assistance to "DAKKAHSIS", "KUTUBKHANAS", "MADRASAS", "DAKKAHS", LIBRARIES, LABORATORIES, RESEARCH INSTITUTIONS AND SCIENTIFIC INSTITUTIONS, MUSEUMS, FORUMS, SEMINARS, CONFERENCES AND ASSOCIATIONS relating to the studies of Islam and Islamic organizations and to establish, erect and maintain all or any of such ones including text books and syllabus on Islamic Studies.

(b) To maintain the existing and, if necessary, to construct and maintain new, Mosques, Muslim burial grounds, Orphanages, Misafir-khannas, Lairs, Athanasies, Bridges, Quays, Electric Posts and Lights, water taps and sanitary installations, rehabilitation Centres, Asylums and Rescue homes beneficial to the Muslim community in particular and useful to the general public at large and to pay salaries allowances

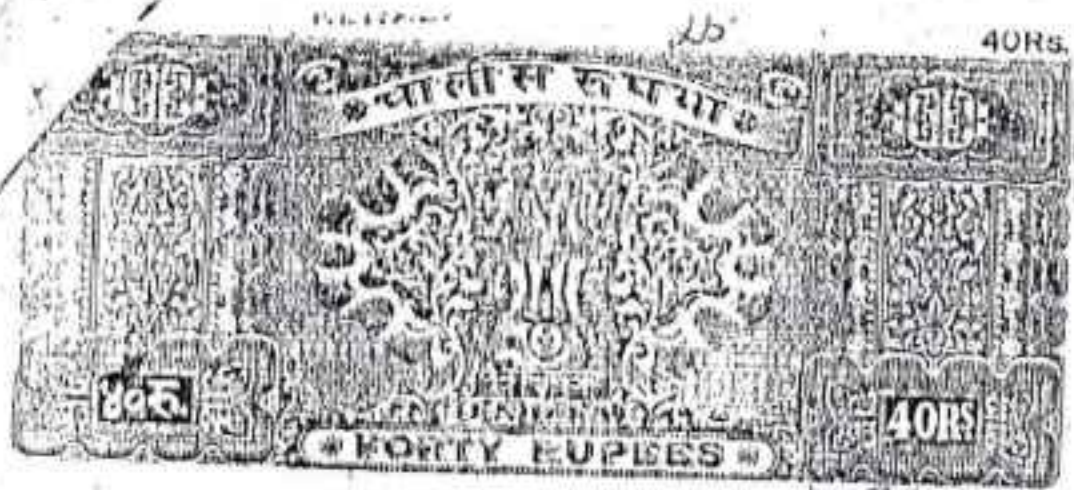

or donations to the offices and employees of Mosque and other Islamic Institutions.

(c) To facilitate and augment the cultural, educational, historic and religious sides of Islam by establishing schools, Colleges and other institutions of higher studies and providing scholarships, prizes, books, fees, stipends, medals and memorial lectures and educational accessories to the deserving students of the Muslim community and to encourage religious institutions and religious activities among the students, particularly of the female sect of Islam.

(d) To help and support the business, Industries and other occupations of the Muslims on the verge of their distress and dislocation and to mitigate the rigour Unemployment by granting financial help to small industries, cottage industries, petty businesses, individual professions and other occupations by way of loans, grants, donations or otherwise and to help the indebted.

(e) To render financial assistance to thutun houses of the poor and feed and cloth the poor and the needy and medical assistance irrespective of caste, colour or creed.

(f) To assist in the cause of removing in marriage of the poor females and to distribute prayer goods to the deserving families of the Muslim Community.

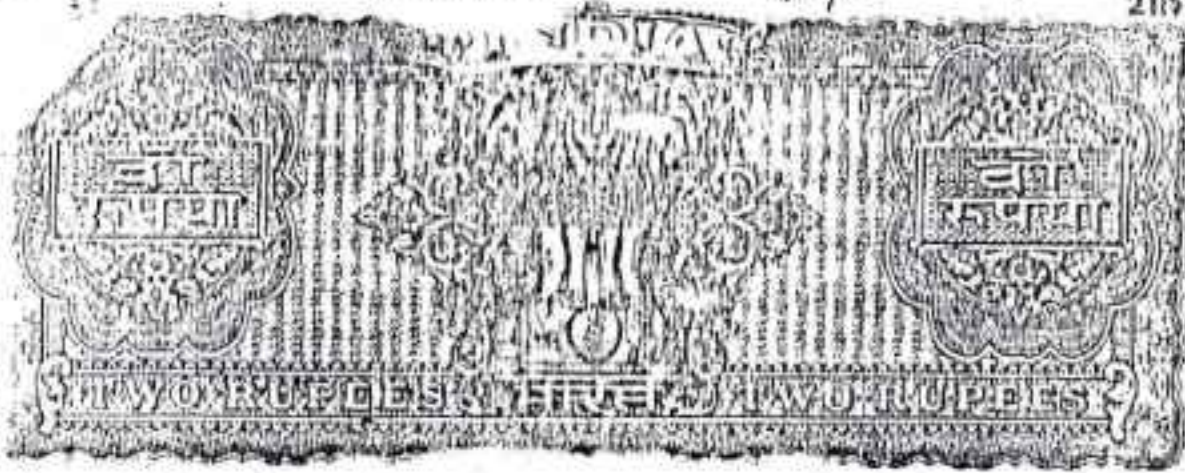

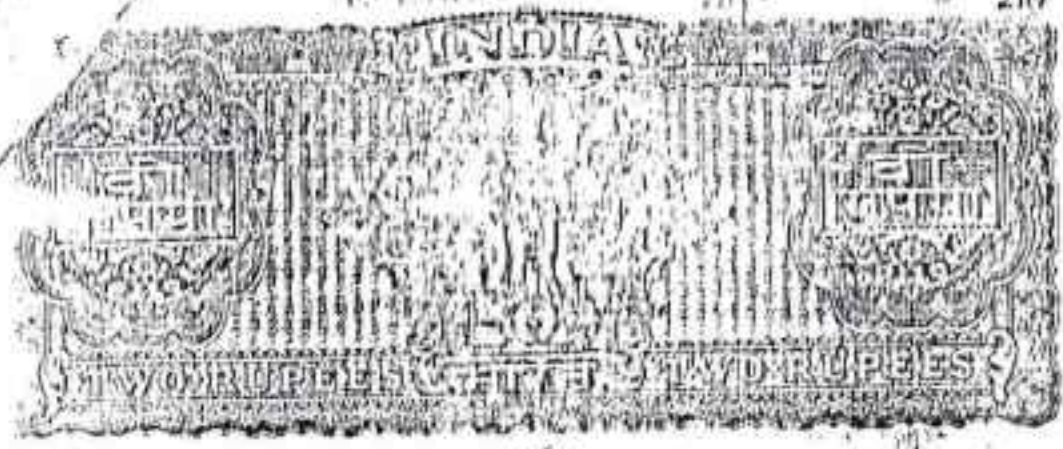

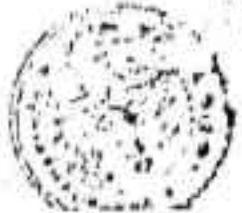
5. CHAIRMAN OF THE BOARD.

We appoint Mr. P. Mohamed Abdul Jalal, S/o. Alavi as the first Chairman of the Board for a period of 2 (two) years from today and on the expiry of this period the Board shall elect one among them as the Chairman and the duration of the period of a Chairman shall be for two years unless otherwise resigned or deposed.

6. DUTIES OF THE CHAIRMAN.

The Chairman will preside over the Board meetings, supervise the functioning of the Board and give necessary directions to the proper administration of the Board and shall represent the Board in all actions, Civil, Criminal or Revenue and in all Offices of the

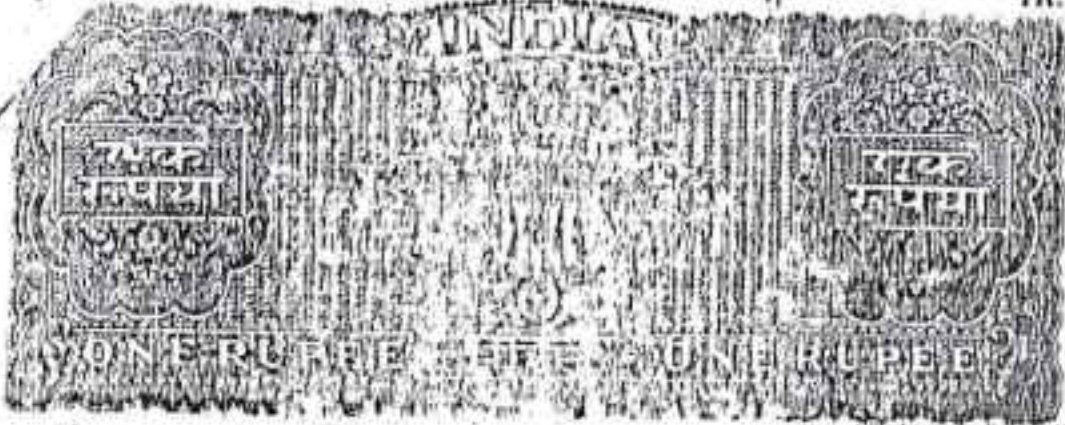

Government, Central or State including Income tax and Sales Tax Officers and Offices of the Municipalities or Panchayaths or other Offices and before all or any authorities of such Offices, unless and until decided otherwise by the Board.

7. SECRETARY OF THE BOARD.

A. In view of the convenient management of the Trust, the Board shall either elect one among them as the Secretary or appoint any from outside as the Secretary of the Board whether salaried or honorary, and the Secretary so appointed shall perform the day-to-day administration and management of the Trust including the preparations of the annual budget. The Secretary will be entitled to such allowance or honorarium, taxa or grant as are decided by the Board according to the circumstances. The Secretary shall not keep in hand an amount more than Rs. 2500/-

X 7. (B) The Board Meeting shall be convened either by the Chairman or by the Secretary or by both or by any Trustees authorised by the Board on giving at least 3 (three) days notice to the Members of the Board, but the Chairman or the Secretary or both or the authorised Trustees shall be bound to convene the meeting within 7 (seven) days of receipt of a notice signed and given by not less than 1/5th (one fifth) of the total members of the Board demanding

to convene the Board Meeting and allowing the matters to be discussed and decided therein.

7. (C). If the Chairman or Secretary or both or the authorized Trustee does not call the Board Meeting within such time as stated above, the members who have signed the notice shall have the power to convene the Board Meeting and discuss and decide the matters given in the Notice.

7. (D). In case the persons entitled to call the Board Meeting under clauses (B) & (C) above fail to carry out their duties or are in any way disabled or incapacitated to discharge their functions by any outside impact or agency or are out of station for a continuous period of 30 days, the Board Meeting can be summoned by not less than 1/5th of the total members of the Board and in the meeting so summoned the Board can appoint a Trustee or Trustees for discharging the functions of the Chairman or Secretary or the authorized Trustee as the case may be until otherwise decided by the Board.

8. FUNCTIONS OF THE BOARD.

The Board of Trustees shall govern, manage and administer the trust and trust properties to the best interest of the trust and its beneficiaries, discharge the duties with due care and ability and fulfil the purposes herein described with utmost sincerity.

9. OFFICE OF THE BOARD.

The Office of the Trust shall be at Perintalmanna but the Board shall have power to shift the Office to any other place in India or open sub-offices in such places as are deemed fit by the Board for the smooth functioning of the Trust.

10. COMPOSITION OF THE BOARD.

The Board which we have constituted and appointed hereby, will be a permanent Board of Trustees and any vacancy in the Board occasioned by death, resignation, dismissal or otherwise shall be duly filled up by nominating members from outside by the remaining Trustees, the nominee being religious, honest and trustworthy.

11. POWER OF THE BOARD.

a. The Board shall appoint the necessary staff, employees

and other officials for the functioning of the Trust and shall have power to decide all matters relating to such appointments and other relevant factors in connexion with the same.

b. The Board shall approve an annual budget for the ensuing financial year categorising the heads of income and expenditure. But the Board is at liberty to expend the unspent amount of one category to the other according to importance, urgency or circumstances, the financial year being April to March.

c. The Board shall have power to accept the Trusteeships, Kuttavalliships, or management of any other Trusts, WAKFS, associations or endowments and such Trusts, WAKFS, Associations or Organisations or endowments shall be administered under the provisions of this Deed.

d. The Board shall have power to acquire, accept or receive all endowments, gifts, grants or donations "Sadakas" or Zakaths" movable or immovable, made to this Trust by assignments or otherwise by individuals, groups, families, organisations or associations, whether incorporated or not, or by any Government, State, Central and all such endowments, gifts, grants and donations "Sadakas" or Zakaths" shall be considered as part of this Trust, properties and their management, income and expenditure shall be unconditionally carried on and used for as per the provisions of this Deed.

e. The Board shall have power to commence, continue and carry on business, commerce and industries like small scale industries, cottage industries, fishing industries, boat building industries etc., and their attached workshops and factories to increase the income of the Trust and to mitigate the rigour of unemployment and the Board shall have power to make regulations, when found necessary, terms & conditions for the effective and beneficial conduct and continuance of such business, commerce and industries and all such regulations,

terms and conditions shall be deemed to form part of this Trust deed.

Provided that no such business, commerce or industry shall be undertaken by the Board until the financial capacity of the Trust in cash is above Rs. 5000/- after meeting the budgetary expenditure.

f. The Board shall not have power to sell the properties of the Trust or any part thereof except in cases of unavoidable necessity and circumstances or for purchasing other more beneficial properties, movable or immovable. But the Board shall have power to pawn, pledge or mortgage the Trust properties to raise funds and loans for the purposes stated in clause (e) above and no such pawn, pledge, mortgage, or sale shall be valid unless made after the decision of the Board by 75% of the existing strength of the Board.

g. The Board shall deposit the funds of the Trust in such bank or Banks as is or are decided by the Board in the name of the Trust and unless and until otherwise decided by the Board the Chairman and Secretary jointly shall have power to negotiate and operate on such bank accounts, by issuing jointly signed cheques or bills and draw amounts, but no Chairman and Secretary shall draw or issue any cheque more than the annual budgetary estimate without the special sanction of the Board.

12. SITTING AND SITTING ALLOWANCES.

The Board shall sit in session at least once in six months and the members are eligible to sitting allowances, both or travelling allowances in such manners as and when are decided by the Board. The Secretary shall submit before the Board in every sitting the working report of the Trust and the budget in the primary session of the year.

13. QUORUM AND MAJORITY.

The Quorum of the Board shall be 60% excluding the Secretary

If not as trustee and all the decisions of the Board shall be in writing and by the majority of the members present. The majority decision of the Board shall not be questioned by any member of the Board except in a court of law, but the Board will have its discretion to review its own decisions.

In case any Board meeting has been adjourned for want of quorum the next meeting shall be called within 15 (fifteen) days of such adjournment and the agenda may be discussed and decided even though it is not attended to by as many members as necessary to fill the quorum.

14. CASTING VOTE OF CHAIRMAN.

Where the Board in session is equally divided in voting, the Chairman will have the right of casting vote and the finality of the matter in dispute will be decided accordingly.

15. ENLARGEMENT OF THE BOARD.

According to the circumstances and necessity of occasions as felt by the Board, the Board is empowered and authorized to enlarge its strength by nominating as many members from outside as it feels necessary.

16. RULES AND REGULATIONS.

The Board by a majority of 75% of its members may frame necessary rules and regulations helpful and ameliorative to the smooth and effective conduct, running and management of the Trust, but such rules or regulations shall in no way be derogative to or circumventing the purpose of this Trust.

17. AUDITING.

The accounts of the Trust shall be audited by a Chartered or otherwise duly qualified accountant. But under such circumstances

an are found by the Board necessary and beneficial to the interests of this Trust, the Board can appoint auditors who are not duly qualified as stated above.

18. DISMISSAL.

Any Trustee or Trustees whose acts and behaviour are found detrimental to the interests of this Trust may be dismissed by the Board by a resolution approved by a majority of 75% of the total strength of the Board.

✓ 19. LEGAL ADVISER.

The Board shall appoint a legal adviser to the Board and the monthly or annual remuneration, travelling allowances or huts etc. shall be fixed by the Board and such appointments shall be for 2 (two) years. But the Board shall have power to terminate the services of the legal adviser at any time with one month's notice.

20. ACT APPLICABLE.

This Trust shall be governed by the provisions of the Indian Trust Act (Act II of 1882)

21. VALUATION.

This Trust is valued at Rs. 5,000/- ✓

22. IRREVOCABILITY.

This Trust is an irrevocable Trust and neither we nor our descendants have any right of authority to revoke it. But the Board by 75% of its majority shall have power to associate or amalgamate with other Trusts constituted for similar purposes or to assign the trust properties in favour of such other Trusts.

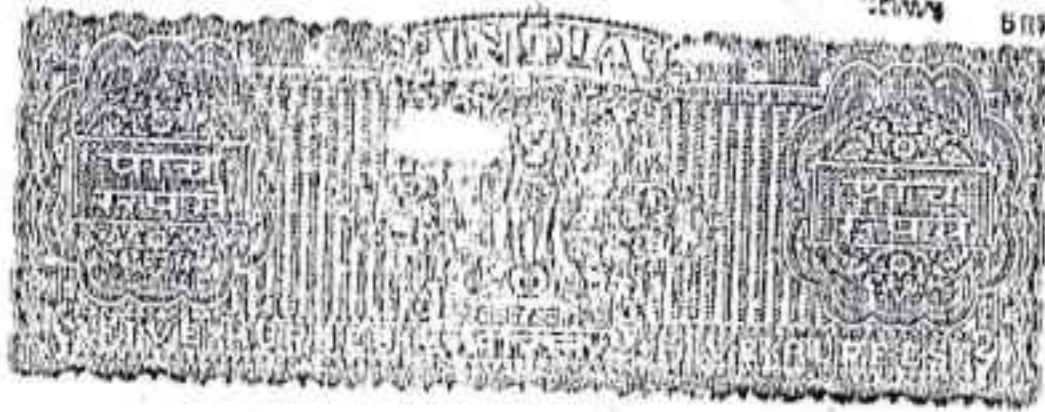

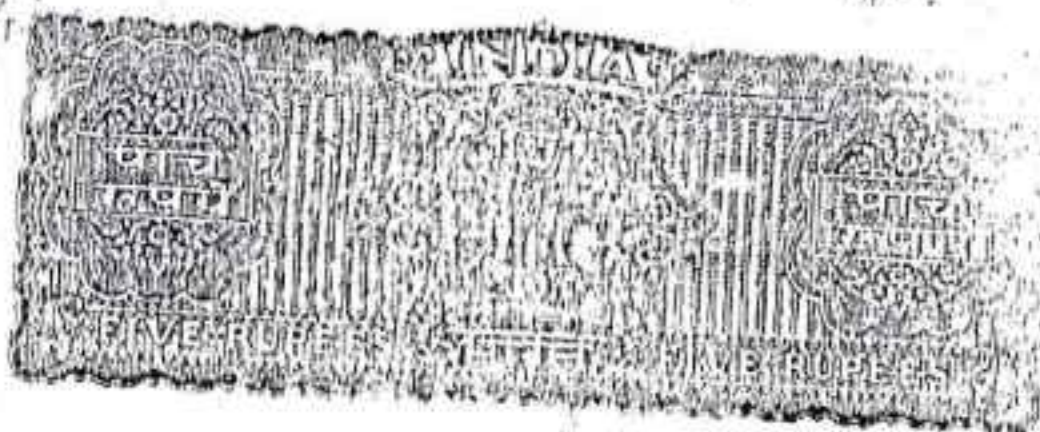

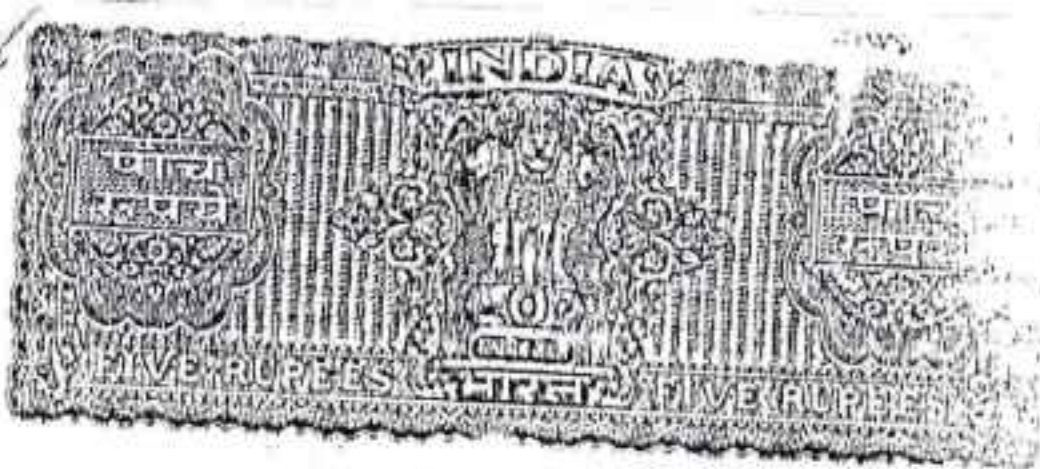

ITEM - 24 (NEW) :- For the good administration of the Trust Management Committee for conducting Schools may be constituted. The management committee shall consist of 7 members. The management committee and the president of the above committee shall be elected by the trust board. The president of the managing committee shall be the manager of the Schools. However if the performance of such management committee is found unsatisfactory it can be dissolved by decision of above 50 % of board members.

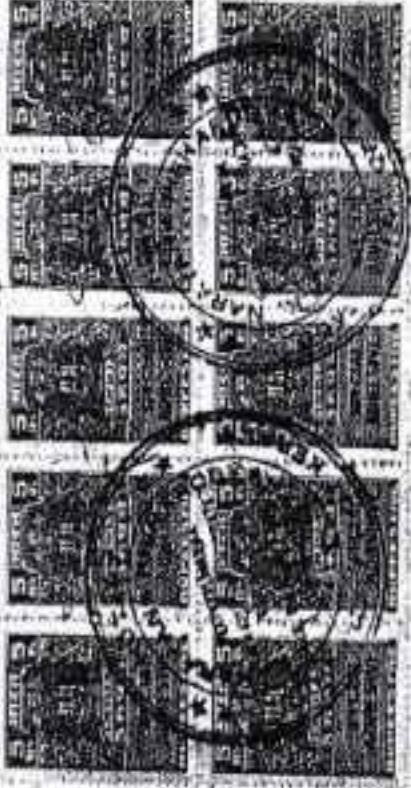
