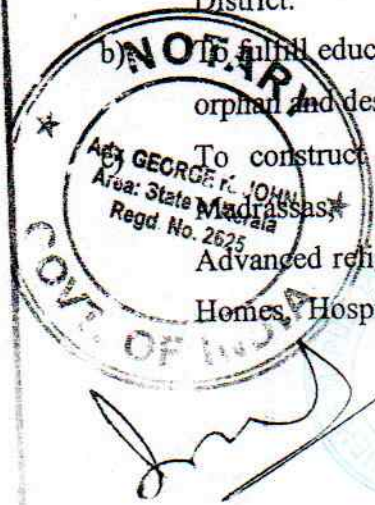

**Homes, Hospitals, Health centers and Mosques.**



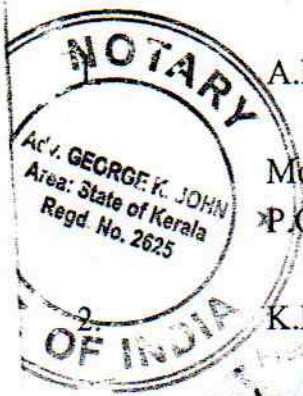
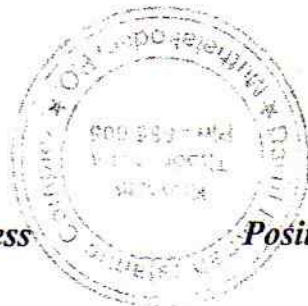

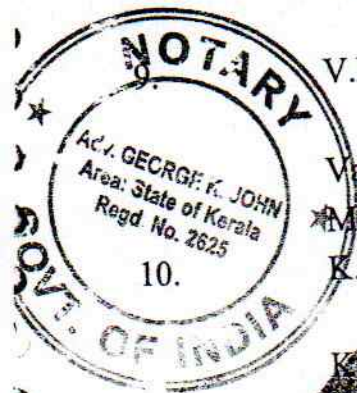
- d) To conduct free Medical camps, blood-testing camps, and to arrange blood donations whenever it is required.
- e) To provide financial assistance to the poor for the construction of houses and to bury the dead bodies of unknown orphans
- f) To keep in possession and lookafter the following properties which are received as wakf one acre and fourteen cents in Survey No. 1542/8 of Annaikannam kara of Karikode village Thodupuzha Taluk, twenty cents of property in survey 1542/9 out of acre ninety eight cents which lies to east of road and where mosque and madrassa situated, forty cents of property on the west of the road. Twenty five cents of property out of one acre sixty two cents and east-west on the road side in survey 1522/1.
- g) To construct, community halls for concentration and propagating spiritual as well as natural studies and for giving leadership for its development.
- h) To keep and maintain the movables and immovable properties which are received either on cost or as wakf.
- i) To work for national integrity and to work for keeping communal Harmony.
- j) To earn and raise sufficient fund, from al possible means, which are not against the laws and principles of Sariyath laws for the development and functioning of the society.

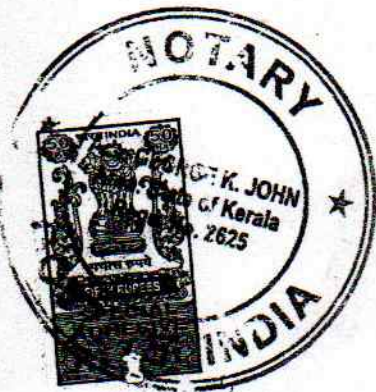
