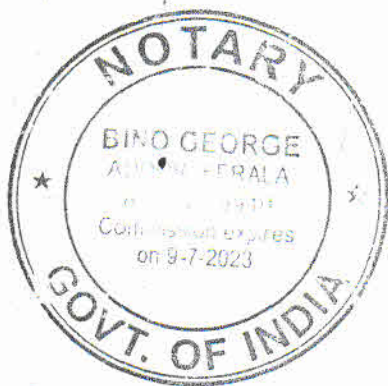

But as it is prescribed vide Ref. no. 2 above, that Fire NOC is mandatory in the Educational sector only for buildings having height more than 15 metres or floor area more than 1000 sq. m., the educational building having a floor area of 800 sq. m. mentioned in your application does not require Fire NOC. Hence the plans, chalan and related documents submitted by you are returned.


Though Fire NOC is not mandatory for your school building, the building owner has made sure that the 10,000/- litre terrace tank, 450 LPM pump, hose reel system and Fire Extinguisher (NBC 2016-part iv-Fire and Life Safety Table 7) installed in the building under fire supervision are properly functioning. Also necessary disaster management training be given to students and teaching and non-teaching staff with the help of the Fire Station, by forming Safety Club.
