



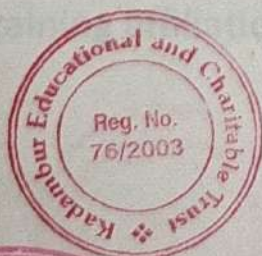

7. 18. That no member of School Managing Committee is related to each other.


