That we the founder trustees have now conveys transfers and grand's unto the TRUST the sum of Rs. 1000 (Rupees One thousand only) contributed by us to have and to hold the same in TRUST for the objective of the TRUST as described below to be used and appropriated by the TRUST in order to carry on and fulfill the objectives and the donors hereby relinquish for all time any claim or interest in the said amount and assets the subject matter of the TRUST.

1. Name of the Trust : The Trust hereby create is a Public charitable Trust and shall be known as **KUTHUBIYYA CHARITABLE TRUST, PANOOR.**

2. registered Office : The registered office of the Kuthubiyya charitable Trust, shall be situated at Panoor, Kannur District. Kerala.
3. Jurisdiction of the Trust : Jurisdiction of the Trust extents to the whole state of Kerala and Mahe.
4. The objects of the Trust are :
  - i) To exercise the duties for the physical and spiritual development of the Sunni Society who follows strictly the path of Ahlu Sunnath Val Jama-ath with the Ash-ari Thareekath by belief and Shafie Madhab by doings.
  - ii) To own, establish, maintain, run, develop, improve takeover, and construct Day cares, Schools, Colleges, Para Medical Institutions Shareeath Colleges, Daewa Colleges and other Educational Institutions.
  - iii) To assist in the establishment, maintenance running, development or expansion of educational centers.
  - iv) To establish run maintain develop improve expand and takeover hospitals Clinics Dispensaries or any other form of institutions in order to provide medical relief to the general public.
  - v) To acquire maintain construct build convert and concrete any building, rest room, crushes, prayer halls, public wells and waiting sheds to the benefit of the general public.
  - vi) To establish run maintain take over develop improve and expand Educational Social Cultural and Industrial Centres Libraries Reading rooms etc.
  - vii) To diffuse and disseminate knowledge among people and propagate and educate the general public in India and for this object to hold discussions study circles Symposium, Seminars and Conferences from time to time.
  - viii) To extent any type of financial assistance to the down trodden and the poor as approved by the Board of Trustees from time to time.
  - ix) To institute all types manage scholarships and other educational aids to the welfare of the students.
  - x) A collective work for the prosperity of the Trust.

5. Members and their Rights

There shall be two types of members:

They are 1) Founder Trustees, 2) Associated Trustees:

i) **Founder Trustees:** Founder Trustee members are the Adhoc Committee members of the former committee. They are 22 members. This Trust comes in to existence by the effort of these members.

- a) These Twentytwo members are collectively known as founder trustees.
- b) Membership fees of these members are fixed to Rs. 1,000/- per head and the entrance fees per head is Rs. 100/-  
These Twentytwo Founder members are the life members of the Trust.
- c) These Twentytwo Permanent members of the Founder Trustees are the Permanent members of the Board of Trustees.
- d) Founder Trustees can nominate any person as his nominee according to his will. He will become a member of Founder Trustee after his death or retirement.
- e) The maximum number of Founder Trustees are limited up to Twentytwo
- f) They are legally bound to obey all the rules regulations and decision of the board of Trustees.

ii) **Associated Trustees:**

- a) "Associated Trustee" members are the life members of the Trust.
- b) Membership Fees of these members are Rs. 2,000/- per head and entrance fees Rs. 100/- per head.
- c) Membership Fees and entrance fees are subject to modification as per the decision of the board of Trustees.
- d) Associated Trustees can elect ten members among them to the Board of Trust.
- e) The duration of these elected representatives to the board of Trustees are limited upto 5 years.
- f) Associated Trustees are legally bound to obey all the rules, regulations and decisions of the Board of Trustees.
- g) If the Board of Trust feels that any members of the Associated Trustee is acting against the Trust. The Board of Trust has the right to terminate or suspend his membership.
- h) The membership Fees and Entrance Fees remitted by the 'Associated Trustee' are not refundable under any circumstance.

## 6) Board of Trustees:

The Total number of Board of Trustees shall be limited to 32 which shall be composed of

- i) Twentytwo Founder Trustees
- ii) Not more than 10 representatives elected from the Associated Trustees.
- iii) Interim vacancies in the Board of Trustees may be filled up by nomination from the respective class of Trustees by the Board.

## 6. Procedure of Administration

## I. General Body

- a) The General Body shall be constituted by the members of Founder Trustees, and associated Trustees.
- b) The General body meeting shall be conducted once in a year

## II. Office bearers

- a) The Office bearers of the Trust can be elected among the 32 members of the Board of Trust.
- b) The Office bearers include President, Two Vice President, General Secretary, Three Secretaries and Treasurer.
- c) Period of Office is limited upto 5 years.
- d) The Office bearers shall be the governing body of the Trust. The governing body should meet at least once in a month.

## 8. Functions and duties of board of Trustees.

- i) It shall be competent for the Board of Trustees from time to time, frame make and enforce all such rules, regulations and or byelaws not in consistent with the express provisions of the deed of Trust as the Board of Trustees may deem proper for securing and facilitating the administration and management in details of the various departments relating to the activities and affairs of the Trust and for convening conducting and regulating the meetings of the Board of Trustees and for appointing Sub Committees and generally for the management and administration of the Trust and also from time to time to repeal, alter amend rescind or add to all such rules regulations and bye laws and also to pass resolutions in connection with all or any of the said matters at their meeting.

- ii) The Board of Trustees shall have power and authority to appoint or engage and at their discretion to remove dismiss or suspend one or more supervisors cashiers managers accountants clerks chowkidars attenders servants securities and other official or employees and persons in permanent temporary or special service in connection with work of the Trust estate Trust founds Trust properties and Trust offices as they may from time to time think fit and to determine their powers and duties and fix their salaries bonus or emoluments and to require security in such instance and such amounts as the Board of Trustees may think fit. The Board of Trustees shall also have power to found and maintain Provident Funds Gratuity Funds Personal and other funds for any employee and make rules and regulations regarding the same.
- iii) The Board of Trustees shall have power in general to acquire all things and do all acts necessary to carry out the objects of the Trust.
- iv) The Board of Trustees shall be entitled to reimburse themselves out of the Trust estate, all expenses incurred in or about the execution of Trust or powers herein or in carrying out the Trust its objects and affairs or the realization preservation or benefit of the Trust Properties. The Board of Trustees shall be entitled to be indemnified by the Trust properties against the consequences of all lawful acts done by the Trustees in the course of discharge of their duties as the Trustee of this Trust and all costs charges and expenses thereof.
- v) The Board of Trustees shall not be entitled to any remuneration and shall work in the honorary capacity. They shall however be entitled to the out of pocket expenses incurred by them in the course of discharging the duties of the Trust.
- vi) The Board of Trustees may at any time invite and receive or without such invitation receive any voluntary contributions either from the members or from any other person or persons by way of donation legacy or otherwise. All such contributions shall be treated as forming part of the trust found being the subject matter of these presents provided that it shall always be for the Board of Trustees in their absolute discretion of decide whether they should inyite and or accept any such contribution and they shall at all times be at liberty of refusal.
- vii) Subject to the provisions herein above. The Board of Trustees shall not keep with them at any time more than Rs.10,000/- (Rupees Ten thousand only) in cash.

- viii) All expenses for and on behalf of the Trust above Rs.15,000/- (Rupees Fifteen thousand only) can only be discharged through an account payee Cheque or Draft.
- ix) The Board of Trustees shall have the power to deposit the Trust's money or any portion thereof in any scheduled bank either by way of Fixed Deposits or in current savings or other deposit account in the name of the Trust.
- x) The Bank account of the Trust can only be opened and operated by the Joint Signature of the President and General Secretary of the Trust.
- xi) Borrowing money from Banks or other Financial or assets of the Trust can be done only by passing a special resolution to that effect by two third majority. The quorum for the special resolution shall be
- xii) The Board of Trustees shall also have power to invest the Trust money in any Government Securities or in any other approved Securities and also to invest in any such manner as may be directed by the Trustees and from time to time vary the investment in which the Trust funds may be invested.
- xiii) The Trust money shall not be invested with any private individuals or firms or association of person or body of Individuals.
- xiv) For the purpose of carrying out the objects of the Trust, the Board of Trustees shall have power to acquire by purchase or on lease or otherwise any immovable properties and in case of vacant land the Board of Trustees shall be at liberty to erect buildings plants and machines thereon and do all acts necessary and incidental thereto.
- xv) It shall be lawful for the board of Trustees to pull down renovate rebuild alter adapt improve add to develop or repair any immovable property comprised in the Trust properties and expand thereon such money out of the Trust fund or the income there of as they may think of it.
- xvi) It shall be lawful for the Board of Trustees at such time or times as the may in their absolute discretion think fit to sell by public auction or private contract or exchange or transfer or assign or grant lease or sub lease for any term however long or otherwise dispose any part of the Trust properties including immovable properties. This can only be done through a special resolution resolved unanimously by the Board of Trustees.

- xvii) The entire control regulations management application and administration of the Trust properties whether capital or income rent interest or profit of any kind shall be in the description of the Board of Trustees.
- xviii) Every power authority or discretion conferred upon the Board of Trustees shall be exercised or signified either by some instrument in writing to be signed by all the member of Board of Trustees or such of them as may present or by the resolution of Board of Trustees or such of them as may be present there and vote at any meeting of the Board of Trustees.
- xix) In case of difference of opinions arising among the Board of Trustees shall have a discretionary power the opinion of the majority of the Board of Trustees present and voting shall prevail and be binding on the majority as well as on those Trustees who may not have voted and if the Trustees shall be equally divided in opinion the matter shall be decided according to the casting vote of the President. The minimum number of members required for the quorum of the meeting is Eleven Board of Trustees Personally present at the time of meeting.
- xx) The meeting of the Board of Trustees shall be held at least once in a 90 days but any number of other meetings may be held as and when considered necessary.
- xxi) A registration certificate and Minutes Book shall be kept by the General Secretary. Minutes of the entry into office of every new Trustees and of all proceedings of the Board of Trustees shall be entered in the minutes book and shall be signed by the President of the meeting either at the conclusion thereof or at the next meeting or when they shall have been fully comprised.
- xxii) An Attendance Register for recording the Trustees present should also be kept by the General Secretary and signed by the Trustees present for the meeting.
- xxiii) Proper and regular books of accounts of all receipts and expenditure of the Trust shall be maintained by the Trustee either in Malayalam language or in English or partly in English and partly in Malayalam.

- xxiv) On the 31<sup>st</sup> day of March every year a general account shall be taken on all the assets and liabilities of the Trust and an "Income and Expenditure Account" for the whole year and a Balance Sheet as on 31<sup>st</sup> March shall be prepared and passed by the general body. The accounts of the Trust shall be audited annually by a Chartered Accountant appointed by the Board of Trustees for the purpose.
- xxv) For moving any special resolution 21 days prior notice containing the details of the resolution should be circulated to the Board of Trustees.

#### 9. Powers and Duties of the Board of Trustees President.

- 1) To chair the meetings of the Trust and control and proceedings.
- 2) To institute conduct deferred compound withdraw or compromise adjust refer to arbitration or abandon legal or other proceedings claims or dispute by or against the Trust or against its officers or employees concerning their affairs of the Trust and to sign and verify plaints written statements affidavits petitions counters memos vakalaths and any other form or forms of statements or documents required for the purpose of any proceedings before the Honorable Court, Commissions or Tribunals, or before any authorities of the Central Government of State Government or any other Local Authority of institution.

#### 10. Power and Duties of the Board of Trustees: Vice President:

The Vice President can chair the meetings of the Trust in the absence of the President and take note of the Proceedings and report it to the president.

#### 11. Powers and Duties of the Board of Trustees General Secretary:

- 1) He shall assist the President in the day to day management of the Trust and carry out the directions given by the President and the decisions of the Board of Trustees. He shall with the consent of the President convene all meetings of the Board of Trustees and other committees.
- 2) To maintain and keep the minutes of meetings and all other records of the Trust.
- 3) To do any act which is required to be done in the normal course of the business for the day to day management of the Trust.

12) Power and Duties of the Board of Trustees : Secretary.

He should assist the General Secretary in the day to day running of the Trust. He can undertake any other work delegated by the General Secretary of the President.

13. Powers and Duties of the Board of Trustees, Treasurer.

To keep and maintain proper books of accounts to record all transactions relating to the funds assets and properties of the Trust and of all receipts income expenses and liabilities of the Trust.

14. Income of the Trust.

Income of the Trust means all income derived by way of donation admission fee entrance fee contributions and income derived by way of dividend or otherwise the investment of Trust Funds including Capital gain or other profit and realization of the investments and shall also include the profit that any amount which is received with a specific direction that such sum shall form part of the corpus or capital fund of the Trust shall yield.

15. Winding up: In the event of winding up of the Trust the surplus of the property or asset if any has to be transferred to a trust having a same objects or to the Government.

RULES

1. Definitions. In these rules unless the context otherwise requires.

- a) Trust means Kuthubbiya Charitable Trust, Panoor
- b) Board Means the Board of Trustees of the Trust.
- c) Institution means any institution or institutions established maintained and run by the Trust in consistence with the aim and objects of the Trust.
- d) Founder Trustees means those Trustees defined in Section 5(i) of the Trust Deed.
- e) Associated Trustees means those Trustees defined in Section 5(iii) of the Trust Deed.
