1. (a) Name: The name of the Trust shall be The MALIK DEENAR ISLAMIC DEVELOPMENT TRUST.

a) Chairman: To control the activities and functions of the Trust.

(b) Acting Chairman: Ordinarily the Acting Chairman shall preside over all the meetings of the General body and the Executive Trustees. In the absence of the Chairman, the Vice Chairman shall preside. Acting Chairman shall have powers to summon the Executive Trustees in emergency. The Acting Chairman will supervise the functioning of the Executive Trustees and give necessary directions for proper administration of the Executive Trustees and shall represent the Executive Trustees in all actions, Civil, Criminal or Revenue, and in all offices of the Government, Central, State or Foreign, including Sales Tax and Income Tax Offices, and Offices of the Municipalities or Panchayath and other Offices, unless and until decided otherwise by the Executive Trustees

(c) Vice Chairman: The Vice Chairman shall discharge duties and exercise the powers of the Acting Chairman in his absence.

(d) Secretary:

1. The Secretary shall be the Principal Executive Officer of the Trust and shall take appropriate steps to carry out its decisions.

2. He shall carry out the correspondence on behalf of the Trust.

3. He shall convene all meetings of the Trust, General body and Board Meeting and maintain a record of the Minutes of all such meetings.

4. He shall be the custodian of all the records and other properties of the Trust.

5. He shall attend to all matters of General administration in accordance with the directions of the Board and keep accounts of the transactions of the Trust.

6. He shall receive and disburse cash, and shall along with the Acting Chairman and Treasurer operate Bank accounts.

(e) Joint Secretary:

He shall assist the Secretary in the discharge of his duties. The Joint Secretary shall, in the absence of the Secretary act as the Secretary.

2. (a) Location of office: The Principal office of the Trust shall be at Adivad - Pallarimangalam. However, the committee may decide to have an office at any other place for the sake of operational convenience.

(b) Jurisdiction: The State of Kerala, The board of directors may extend activities of the Trust to form new units at any other area in the State. The units so formed shall function in accordance with the units by executive committee to suit the special needs. All units in the State shall be deemed to have been formed under these rules and continue as decided by the executive committee.

3. Aims and Objects: The Trust is formed to work for the educational, social and economic development of the people in all possible ways. The institutions established and administered by the Trust shall be entitled for all rights and privileges guaranteed under the articles 25 to 30 of the constitution of India.

#### 4. Program of Work:

The Trust shall:

(a) Promote higher and technical education, and improve standard and quality of education among the people in general, minorities and backward classes in particular.

(b) Establish and Administer English medium schools and colleges, technical schools, madrassas, Arabic colleges, Yathim Khanas, working women's hostels, L.K.G and U.K.G. etc.

(c) Establish hospitals, clinics and medical centres.

(d) To assist, support, accelerate, facilitate and propagate education to the members of the community.

(e) To establish a scholarship fund to promote higher and technical education among from the people of our country to give scholarships, stipends, loans, grants etc. to the poor and deserving students.

(f) To establish and run hostels and Auditorium for Public.

(g) To establish marriage fund and assist marriage of Poor girls in the Society and to extend medical aids to poor patients.

(h) To provide interest free loans, grants and subsidies to the small traders.

(i) Raise funds by donations, subscriptions, contribution or by increasing mutual funds, units, shares, debentures etc.

(j) Do all other lawful acts, deeds or things as the Trust may consider incidental to the attainment of

any of the objects of the Trust.

(k) To foster and propagate the true teaching of Islam among the members of the Muslim community in particular and the general Public at large.

(l) To collect valuable Islamic Literature and to Publish it and to facilitate Islamic Cultural renaissance of the community.

## MEMBERS

### Admission of members

(a) Any person desirous of becoming a member by fulfilling the condition stipulated above may apply for admission in the form prescribed.

(b) The membership certificates will be issued as per rules.

## GENERAL BODY

(a) The General Body of the Trust consist of all members who has received membership certificate from the Trust.

(b) The General Body shall be the supreme authority of the Trust. It shall have power to condone the defects in the procedure and to modify if necessary decision of the Board.

(c) The General Body shall meet every Quarterly.

(d) The General Body shall have powers to make amendments to these rules and regulations placed before it, in accordance with the procedure prescribed.

(e) The General Body shall have powers to consider and dispose of application for membership.

(f) Any member from the Executive Trustees is at liberty to take leave from the activities of the Trust with prior approval.

(g) The withdrawal of the participation will be effected to the Executive Trustees within two years from the date of giving notices to the Board, and within one year to the other members.

(h) The members of the Executive Trustees may not exceed 14 in number.



- (c) The Executive Trustees of the Trust constituted by the members shall govern manage, administer the Trust in the best interest of the Trust and its beneficiaries, discharge the duties with due care and ability and fulfil the purposes herein described with almost sincerity.
- (d) To raise funds, donations, subscriptions and other forms by beneficiaries.
- (e) To appoint necessary staff, employees, other officials for the functioning of the Trust and shall have power to decide all matters related to appointments and other relevant matters in connection with the same.
- (f) To acquire and hold properties for all kinds to purchase, to transfer to sell, lease, mortgage or otherwise encumber such properties.
- (g) To invest funds in shares, securities, fixed deposits or other business industrial enterprises.



(f) Treasurer:

The Treasurer shall join with the Acting Chairman and General Secretary in matters relating to monetary transactions. He shall also present the Annual budget in the Trust meeting. He is also empowered to join with the Acting Chairman and Secretary in operating the Bank accounts. An amount exceeding Rs. 1000/- will be deposited in the banks.

(g) Technical Advisors:

- (1) Engineer: The designing of the construction works to the Trust will be made by the Engineer.
- (2) Doctor: The Doctor will be in charge of the Medical Institutions.

### MEETING OF THE BOARD AND EXECUTIVE TRUST

(a) Meeting of the Executive Trust:

In consultation with the Acting Chairman the Secretary shall convene meetings of the Executive Trustees, sending atleast One week's notice to the members. But Extra Ordinary meeting shall be convened with 24 hours notice. The Executive Trustees shall meet at least once in a month. The quorum of the meeting shall be above 50%.

(b) Meeting of the Trust:

It is mandatory on the part of the Trust to convene a General Meeting of the Trust at least once within three months. It also requires seven days notice with the items of agenda. The quorum of the meeting shall be 2/3rd of the total strength of the Trust.

(c) Annual General Body Meeting shall be convened before 30th April of every year. The members are entitled to receive annual report, Audited Balance sheet of accounts and a Budget before 14 days prior to the meeting. The quorum of the meeting shall be 2/3rd of the total strength of the Trust. The Agenda shall also include election of two auditors, Extra Ordinary meeting shall also be convened if required 2/3rd members of the total strength of the Trust along with the Agenda.

### ADVISORY BOARD

There shall be an Advisory Board for this Trust only for give advises. The IMAM of the Central Juma Masjid Adivad shall be one of the member of the Advisory Board. The other members shall include renowned persons each from social, cultural, political and educational fields selected by the Executive Trustees.

### DISCIPLINARY ACTIONS

be suspended by the Executive Trust by a resolution approved by Majority of 2/3 of the total strength of the Executive Trust and suitable disciplinary action can be taken as per the exciting law on practice in the subject.

2. If a Executive Trust member continuously absence for Three Executive meeting with out assigning any reason his membership shall be ceased to exist.

### NOMINATION

A member is entitled to appoint a nominee for his behalf at his option. However the Board of Trustees are for life and in the vacancies if any caused by death, resignation, removal or otherwise shall be duly filled by the nomination from among the family members who is acceptable to and decided by a simple majority of the Board of Trustees.

### BY LAWS AND RULES

The Meeting of the Trust shall have power to frame rules and By-Laws, regulations, helpful and ameliorative to the conduct and running of the Trust, but the regulations so framed shall in no case be derogative or circumventing the directions of this Deed.

### AUDITING

The Account of the Trust shall be audited by duly qualified accountant, but the Board of Trustees i.e., General Body can also get the accounts audited by appointing other persons duly qualified according to the circumstances.

### ACT APPLICABLE

The Trust is to be governed by the provisions of Indian Trust Act (Act 11 of 1882). This trust is execute and register by the six trustees:




