WHEREAS the settler above named has subscribed an amount of Rs 10,000/- (Rupees Ten thousand only) to the schedule shown below as a Trust called "PANOR M.E.S TRUST, PANOR" for the sole Educational and Charitable intention and purposes hereinafter appearing.

AND WHEREAS the trustees have also accepted the trust fund as stated above.

The trustees have, at the request of the Settler agreed to act as the first trustee of the said Trust and these presents.

NOW IT IS HEREBY DECLARED BY THE SETTLER AS FOLLOWS:

1. The name of the Trust shall be "PANDOR M.E.S TRUST, PANDOR" and the present office of the Trust shall be P.P 2/31 at Pandor.
2. The Trustees shall always be life members of the M.E.S who shall each contribute Rs 10,000/ as membership fee.
3. The aim and objects of the Trust shall be
 - a) To bring awareness of Education among backward classes especially muslims.
 - b) To establish and run Nuraery and English Medium Schools, Industrial Training Institutions, Teachers Training Schools, Computer Education Centras and other Vocational Courses for youth.
 - c) To organise and run for the upliftment of womenfolk charitable institutions such as Tailoring Training Centre, Girls High School, Home Science Colleges, Nursery Training Centre, Child and Health Care Centres etc;
 - d) To run institutions for rehabilitation of physically disabled and mentally retarded including deaf and dumb.
 - e) To train and coach suitable candidates from backward classes for U.P.S.C, Administretive Central Services and allied services.
 - f) To run adult education centre
 - g) To establish and run Islamic research institutions;
 - h) To establish Library and Educational Research Centres
 - i) To establish an Auditorium
 - j) To promote sports and games

6) FUNCTIONS OF THE OFFICE BEARERS:

a) Chairman:

He shall preside over all the meetings of the Trust and other functions if any conducted by the Trust. He shall supervise the activities of the Trust.

b) Vice Chairman:

In the absence of the Chairman, the Vice Chairman shall preside over the trust meetings. He shall supervise the activities of the Trust along with the Chairman and assist him in discharge of his functions.

c) General Secretary:

The General Secretary shall attend to and look after the day to day affairs of the Trust. He shall convene all meetings, in consultation with the Chairman, prepare agenda, keep and maintain all records, attendance books, minute books, and prepare reports. He shall convene meetings of the Trust or of the Managing Committee also when 1/3 of the members concerned request in writing to convene such meetings, which he shall do within 10 days of the receipt of the requisitions.

d) Joint Secretary:

The Joint Secretary shall assist the General Secretary in his functions. He shall also discharge the functions of the general secretary in his absence.

e) Treasurer:

It shall be the responsibility of the treasurer to keep the financial accounts of the Trust. He shall be entitled to keep with him an amount not exceeding Rs 5000/(Rs. Five thousand

7. MEETINGS:

The trustees shall meet at least once in 3 months or as and when exigencies arise. The notice of the meeting under ordinary circumstances shall be served on the trustees by the General Secretary at least three days in advance. In case of emergencies 24 hours notice will suffice. The general secretary shall circulate the agenda along with the notice. However the notice for annual meeting of the Trust shall be served at least a month in advance.

b) Questions resolutions etc if any, to be mooted at the meeting shall be given in writing to the General Secretary at least a day in advance.

c) Quorum for the meeting of the Board of Trustees shall be 1/3. In case, two consecutive meetings of the Board of Trustees are not held for want of quorum, the quorum for the third meeting shall be one fourth of the total trustees.

d) The Chairman of the Trust shall be entitled to preside over all the meetings of the trustees and he shall have casting vote. In the absence of the Chairman, the Vice Chairman will preside and in that case, he shall have the power to exercise casting vote. In the absence of both the Chairman and the Vice Chairman the remaining trustees shall choose one amongst them to preside over the meeting and he shall also exercise the power of casting vote.

B. The Trustees shall have power of nomination to the Trust.

Such nominee shall be an immediate relative of the Trustee.

In case the Trustee is abroad his nominee shall observe the

proceedings of the Trust Meetings. If any vacancy arises in the board of Trustees on account of resignation, death or incapacity, his nominee shall become the Trustee. Once the nominee becomes the Trustee, he ~~or she~~ shall have all the powers exercised by the Founder Trustees.


9. The Trustees shall have power to frame rules or bye-laws for regulating the conduct of the business to be transacted by the trustees in fulfilment of the aims and objects of the Trust.

10. Any question arising in the administrations of the trust shall be decided by the majority of the trustees acting for the time being.

11. After defraying all necessary expenses incurred in realisation of the income of the subject matter of the Trust, the balance of the income shall be deposited in any Nationalised or scheduled bank.

12. The Trust Chairman shall supervise the functioning of the Trust and shall represent the Trust ^(in all) actions, civil, criminal or revenue and in all offices of the Government, Central or states or the local bodies, undertakings or other offices and before all or among the authorities of such offices. However, it is within his power to nominate any Trustee or Trustees to act on his behalf for this purpose in case of specified undertaking or for a fixed period of time.

13. The bank account of the Trust shall be jointly ⁽ⁱⁿ⁾ the name of Chairman, General Secretary and the Treasurer and shall be operated by any two of the three. But they shall not draw any amount more than the annual budgeting estimate without the special sanction of the Trustees.

14. The Managing Committee shall meet at least once in two months and the members attending the meeting shall not be eligible for any sitting allowances. The general secretary shall submit before the Committee in every sitting the working report of the Trust and the budget in the primary session of a year.

15. The Board of Trustees shall consider and adopt a budget annually as is decided upon by them.

16. The Board of Trustees shall have power to accept or receive all endowments, gifts, grants or donations, zakat, movable or immovable properties made to this Trust by assignments, or otherwise by individuals, groups, families or organizations, or associations whether incorporated or not or by any government and all such endowments, gifts, grants, donations or zakat shall become the property of the Trust and shall be administered for pursuing the aims and objects of this Trust and in accordance with the provisions of this deed.

17. The Board of Trustees shall also have powers to purchase properties with the Trust fund. They have also powers to sell whole or any portion of the Trust property in the interest of the Trust.

Any Trustee or trustees who act or do anything detrimental to the interest of the trust may be dismissed by the Board of Trustees.

at a meeting of the Trustees specially convened for this purpose and by a resolution approved by all other trustees present in the meeting. Notice for such meeting shall be served at least 30 days in advance. Quorum for this meeting shall be 2/3 majority of the total trustees.

19. The financial year of the Trust, shall be for a period of 12 months commencing from the first day of April and ending on the 31st day of March next year.

20. Account of the Trust shall be audited by a chartered accountant or any other persons appointed by the trustees in this behalf.


21. The Trustees may exercise all the powers and rights vested on them by resolution duly passed at the meeting of the Board of Trustees.

22. In the event of difference of opinion the majority opinion is to prevail. None of the Trustees shall be entitled to any remuneration. It is hereby specifically declared that the corpus or the income from the Trust properties and the funds collected as specified above shall not be used for the benefit of the Trustees.

23. Any amendment to this deed shall be made at a meeting specially convened for the purpose and shall be by 2/3 majority of the total trustees.

24. In all other matters not specifically provided for herein the Trustees shall function in accordance with the provisions of the Indian Trust Act 1882.

25. When the Trust become extinct all the assets of the trust shall vest with the Kerala State Muslim Educational Society.







It is expressly declared that no part of the Trust Property or its income shall be applied for any purpose which is not considered by law to be in furtherance of objects set forth in the Trust deed and nothing herein shall be considered to authorise the Trustee to utilise the Trust Property or its income for any purpose other than the objects set forth in the Trust Deed.

11. No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of section 2(15), 11, 12 and 80G of the Income tax Act, 1961 as amended from time to time.

10. The funds of the Trust shall be invested in the mode specified under the provision of section 13(1) (d) read with section 11(5) of the Income tax Act 1961, as amended from time to time.

9. The Trust shall not receive any donation from abroad.

8. The Trust shall not receive any total return in the corresponding year nature if any, should not exceed 5% of its expenditure of any year, which is a proportion.

7. It is expressly declared that

the trust deed of the trust, the terms of the trust shall be AT Will. That is, it shall continue till the board of trustees resolves to dissolve by winding up by an unanimous resolution. In the event the Trust gets extinguished or dissolved, the Trust Property shall be realised and the amount so realised (after meeting the expenses of realisation) shall be utilised for meeting all other expenses and liabilities of the Trust and any amounts left over shall be donated to any similar institutions whose objects are similar to those Trust having registration under Section 12A(a) of the Income tax Act 1961 or to Government and shall in no event be distributed amongst the trustees.

14. Trust shall be irrevocable
