A trust deed was signed to form a public charitable trust for the stated purposes and activities and to achieve the socio-cultural development objectives described below.

**1. Declaration** - We have long dreamed of forming a trust with the aim of establishing English medium schools, colleges and technical educational institutions to enable children from all communities, especially the Muslim community to pursue higher education. We have raised the initial funds for this purpose and are now making this dream a reality.

**2. The name of the trust will be** - Right Path Educational Trust, Muvattupuzha.

**3. Registered office and address:**

The registered office of the Trust will be at the Right Path Educational Trust Building on Kavunkara Market Road. (Kavunkara, Market P.O. Pin 686 673) The headquarters may be shifted to another location if deemed necessary by the Trust members.

**4. Scope of operation-** All districts of Kerala.

**5. Declared Objectives:**

a. To start necessary English medium schools, colleges, technical institutes, madrasas, Arabic colleges, orphanages, working women's hostels, L.K.G., U.K.G., nursery schools, etc. to enhance the quality of education of children belonging to various communities in the state.

b To provide scholarships, stipends, loans, etc. for higher education to deserving children from economically backward backgrounds.

c . Establish hostels, recreation centers, etc. for students and low-income employees.

d. Arrange expert training facilities for deserving children for all-India level competitive examinations.


e. Provide financial assistance for higher education to needy and talented male and female students.

- f. To start necessary vocational training centers, industries, etc. for unemployed and deserving people in a manner that will increase the income of the trust.
- g. To raise funds to provide financial assistance for the marriage of economically backward Muslim girls and to provide medical care to needy patients.
- h. Build and provide houses for homeless and needy people.
- i. Establish an interest-free financial institution and provide interest-free loans to the economically backward.

#### 6. Governing body


Initially, there will be a Board of Directors of 11 members and when expanded, there will be a Board of Directors of 15 members. The Board of Directors will consist of a Chairman, a Vice Chairman, a General Secretary, two Secretaries and a Treasurer as described below.

7. Expansion of the Governing Body:- The membership of the Trust may be increased by adding members from outside by charging membership fees after assessing the needs and circumstances. The total number of members in such additions should not exceed 100.

8. Powers and duties of the Governing Body

a) The Trust shall have the right to appoint employees required for the administration of the Trust.

b) An annual budget should be prepared and approved for clarity of income and expenditure figures.

c) The Governing Body shall have the power to accept gifts, financial assistance or contributions from individuals, groups, families, organizations or the Central and State Governments. All such receipts shall be added to the assets of the Trust.

d) The Trust Board shall not have the right to sell the properties of the Trust for any reason other than to acquire more convenient immovable and movable properties. However, in unavoidable circumstances, the Trust Board shall have the right to mortgage the properties of the Trust subject to the decision of 75% of the total number of members of the Board.

e) The funds of the Trust shall be deposited in bank accounts in the name of the Trust. The Chairman, General Secretary and Treasurer shall jointly conduct bank transactions.


f) The Governing Body shall collect membership fees and deposit them in the Trust Fund and utilize the funds for purchasing new items to implement the objectives of the Trust.

#### 9. Tenure of the Governing Body

The term of the Governing Body shall be for three years. On the expiry of the term, a Governing Body of not less than 11 members shall be elected from among the Trustees. Subject to the approval of two-thirds majority of the Trustees, three of the above 11 members shall resign or be replaced by drawing lots. These procedures shall be followed in the elections held every three years. No person shall hold the same office position for more than two consecutive terms. However, if the Committee deems it appropriate, the persons concerned may be requested to continue in their respective offices with the consent of two-thirds of the Trustees.

#### 10. Duties of the Governing Body Members

**1. Chairman :** The Chairman shall preside over all Executive Committee and General Body meetings. In the absence of the Chairman, the Vice-Chairman shall preside. In the absence of the Chairman and the Vice-Chairman, one of the members of the Committee shall preside. The Chairman shall have the power to call emergency meetings of the Governing Body. The Chairman shall supervise the administration of the Governing Body. The Chairman shall represent and appear on behalf of the Governing Body in all transactions and proceedings involving the State Government, Central Government, Semi-Government and Judiciary.

**2. Vice Chairman:** In the absence of the Chairman, all duties and powers decided by the Board of Trustees shall be vested in the Vice Chairman.

#### 3. General Secretary –

A) The General Secretary shall implement the decisions of the Governing Body as the Chief Executive Officer of the Trust.

b) Conduct the Trust's correspondence.

c) Convene all general meetings and committee meetings of the Trust.

- d) Keep all records of the trust.
- e) Add members to the trust subject to the approval of the governing body.
- f) Keep a written record of the income and expenditure of the trust and present it to the board of directors and the general meeting.
- g) Issue receipts for amounts received as membership fees, donations, etc. Hand over the amounts to the treasurer or deposit them in the bank account as appropriate.
- H) Implement the decisions of the Trust Governing Body.
- i) Manage the bank account of the trust jointly with the Chairman and Treasurer.
- j) Perform such special duties as may be assigned by the general meeting of the trust or the governing body.

**4. Secretaries :-** The secretaries shall assist the General Secretary in official matters. In the absence of the General Secretary, they shall perform the duties of the Secretary with sincerity and responsibility.

**5. Treasurer -** To conduct bank transactions in collaboration with the Chairman and General Secretary and deposit amounts exceeding Rs. 1,00,000 (one lakh) in the bank account of the Trust.

#### **11. Trust Committee Meetings**


The General Secretary shall convene the meetings of the Governing Body in consultation with the Chairman. One week's notice shall be given to the members. However, in the case of extraordinary meetings, 24 hours' notice shall be sufficient. The Governing Body of the Trust shall meet once a month and the minimum quorum for the meeting shall be 7.

#### **12. Trust General Meeting**

The general meeting of the trust shall be held once in 3 months. Notice shall be given to the members 7 days in advance along with the agenda. One-third of the total members of the trust shall be the minimum quorum

The annual general meeting shall be held by the 30th of April in each year. The annual report, audited balance sheet accounts and budget shall be provided to the members 14 days before the annual general meeting. In the year of the election of the governing body, the election of the governing body and the election of two auditors shall be included in the agenda.

### 13. Advisory Committee

The Trust shall have an Advisory Committee. Three of the members of the Advisory Committee shall be the Imam of the Central Mahal Jama'at, the Mahal President and the Mahal General Secretary. The other members shall be well-known people in the social, cultural, political and educational fields.

### 14. Disciplinary proceedings

(1) If the actions of any member of the Trust are found to be contrary to the objectives of the Trust, he may be removed from the Trust by a resolution passed by a majority of 75% of the total number of members of the Trust.

(2) A show cause notice shall be given to the tenant 7 days prior to such removal and an explanation shall be sought.

(3) If any Board member fails to attend three consecutive Board meetings without any reason, his/her membership shall be terminated.

### 15. Nomination


A trustee has the right to appoint a nominee for the position and the nominee will become a member after the member's term. However, if he/she deems it necessary, he/she may request in writing to the General Secretary to replace the nominee and make another nominee and the new nomination may be accepted within one month with the approval of the committee.

### 16. Bylaws and Rules

The Trust Board of Directors has the right to formulate rules and regulations that are conducive to the prosperity and welfare of the Trust. However, they should never be contrary to the objectives and directives of this Trust or be detrimental to it.

## 20. Cases against the Trust

Cases against the trust or the trust's assets fall under the jurisdiction of the Muvattupuzha Court.

## 21. Capital

The capital of this trust shall be Rs. 27,000 (twenty-seven thousand) collected from the initial trust members at Rs. 1,000 each.
