As per the Maharashtra Fire Prevention and life safety measures Act 2006, Rule 2009 & Amendment Act- 2023 Under Section 3 (1) (b) Sub Section (b) Final Fire Safety Approval Certificate is hereby granted to the Educational (Ground to 2 Floors) cum Residential Building of Ground to 1 Floor, having sanctioned and Existing height 10.95 mtr comprised of Educational (Ground to 2 Floors) cum Residential Building of Ground to 1 Floor and Total built up area 3407.27 Sq. Mtr. belonging to M/s. Adoration Service Society, Sanjo Public School, On Plot No. 1, C.T.S. No. 15, 16, Sheet No. 01, Mouza- Sulezhazri, Tal.- Nagbhid, Dist.- Chandrapur and has complied with the fire prevention and safety measures in accordance with the fire prevention and life safety measures act 2006 & Amendment Act- 2023 (herein after referred as said act.)

The Final Fire Safety Approval Certificate for Educational cum Residential Building, Ground to 2 Floors is issued on the basis of the inspection report of Nominated Officer dated 07.11.2023 and certificate "A" (as per the provisions of said act 2006, Rule 2009 & Amendment Act- 2023) dated 08.10.2023 by the Licensed Agency M/s SafeIndus Absolute Pvt. Ltd. (License No. MFS-LA/RF-153, RD-144) regarding the compliances of the fire prevention and life safety measures on following conditions as prescribed in the said act 2006, Rule 2009 & Amendment Act- 2023.

1. Under the Sub section (3) of section 3 it is the responsibility of the owner or the occupier as the case may, shall furnish to the Chief Fire Officer/ Nominated Officer a certificate in a prescribed form twice in a year i.e in the month of January and July regarding maintenance of fire prevention and life safety measures in good repair and efficient condition as specified in sub section (1).
2. Under Sub section (4) of section 3, No person shall tamper with alter remove or cause any injury or damage to any fire prevention and life safety equipment installed in any such building or part thereof or instigate any other person to do so.
3. The undersigned reserve the right to add/delete or amend any recommendation deemed fit during future inspection and due to up gradation of firefighting monitoring system of this department in interest of life safety.
4. Any additional construction or change in use of the building or part there of shall render this certificate cancelled and invalid.
5. The owner or occupier shall pay annual fee at the rate of 1% of the minimum fees specified in schedule II as per section 11(1) and 14(4).
