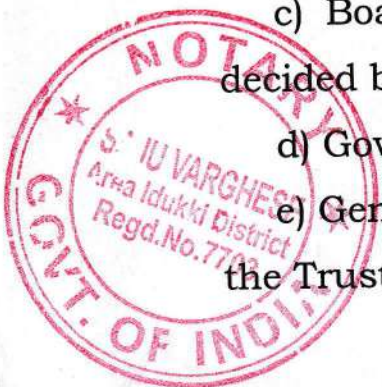
1. **Name of the Trust** : The name of the trust shall be **SREE NARAYANA VIDHYAPEETAM CHARITABLE TRUST**

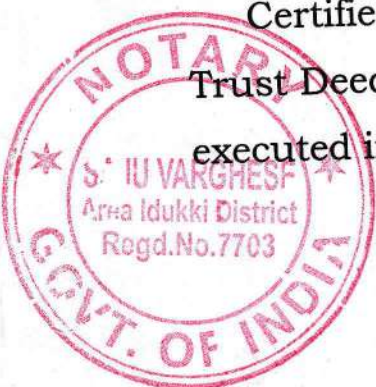
