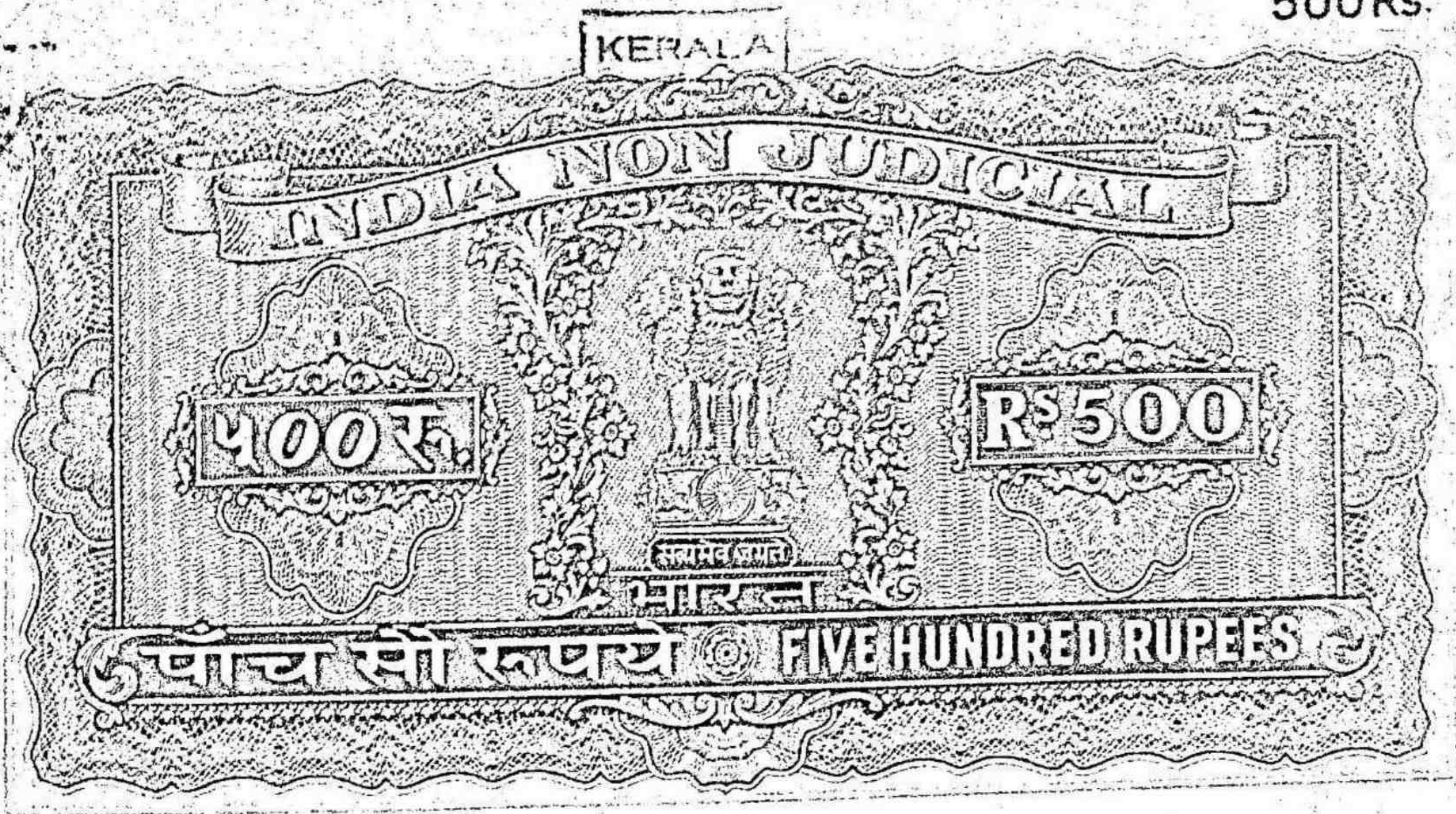

TRUST DEED

TAGORE CULTURAL & EDUCATIONAL CHARITABLE TRUST RAJAPURAM

This deed of Trust executed on the 16th day of February Nineteen Hundred and Ninety Five between (1) Shri. Sasikumar P.A, S/O T.Appa, age 29, Social Worker, Maniyankott House, residing at Palachal, Balal Village (2) Shri. V.Lohithakshan, S/O K. Chathu Nair, age 29, Social Worker, Panathady Village, Pathickara House, (3) Shri.Chacko Chacko, S/O P.O. Chacko, age 25, Pullazhiyil House, residing at Rajapuram, Kallar Village (4) Shri. Mathew (Rtd. H.M), S/O Pothan, age 61, Cheruvellil House, Painikkara, Rajapuram. (5) Shri. Moncy Chacko, S/O P.K. Chacko, age 25, Pullazhiyil House, Rajapuram P.O (6) Shri. Steephan,C.L., S/O Lucka Cherapurath, age 29, Social worker, Cherapurath House, Panathady Village, (7) Shri. Monachan Chacko, S/O P.K. Chacko, age 30, Social worker, Pulliazhiyil House, residing at Rajapuram, Kallar Village, (8) Shri. Chacko Kuruville, S/O P.K. Whereas the Trustee are desirous of forming a Trust for the Educational uplift and welfare of the weaker section and also to establish and run educational Institution under the Trust, have decided to establish a Trust called "TAGORE CULTURAL & EDUCATIONAL CHARITABLE TRUST, RAJAPURAM, contributing a sum of Rs. 8,000/- (Rupees Eight Thousand only). Each trustees contributed a sum of Rs. 1,000/- (Rupees thousand only).

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:-

1. The name of the Trust shall be "TAGORE CULTURAL & EDUCATIONAL CHARITABLE TRUST, RAJAPURAM.
2. The Registered office and Head quarters of the Trust shall be at Rajapuram, and the Trust shall be a public charitable educational and cultural Trust constituted for the benefit of the weaker section in the Kasaragod District.
3. The objects of the Trust shall be :
 - (a) To provide Establish, endow, maintain control and manage schools, colleges, and other educational Institutions and also the institutions for the uplift of the weaker sections and children and to do all act and things necessary for or conductive to the promotion of knowledge and to conduct to schools and colleges for Pre-primary, Primary, Secondary and higher.

commercial, Technical and Industrial education and to do all other necessary related to these.

(b) To carry out objects of public utility, such as village uplift rural reconstruction community development welfare of woman and children promotion of cottage industries and to start establish, d conduct, take over, maintain and manage and help any institution considered necessary to secure objects.

(c) To give scholarships, freeships, prizes and assistance to students to help them in their studies.

(d) To purchase, acquire on lease or otherwise immovable properties including building and to construct maintain and manage the same or other immovable properties necessary for the purpose of the Trust.

(e) To accept donations in each or kind and to raise funds by arranging charity show, by accepting fees and subscriptions and other methods.

(f) The Trustees shall be competent to raise loans, overdrafts, advances from banks or from any other source with or without securities and to pay interest charges etc. on such loans advances overdrafts etc. provided that for creating charges on the immovable properties for the loans overdrafts etc. so raised the decision shall be unanimous.

4. BOARD OF TRUSTEES

(a) It is hereby stipulated and agreed upon that there shall be a board of Trustees for TAGORE CULTURAL & EDUCATIONAL CHARITABLE TRUST, RAJAPURAM, consisting of not more than eight members at any time.

(b) The Trustees named herein shall constitute the Board of Trustees (1) Shri. M. A. Mathew shall be the Chairman and

Chacko Chacko shall be the Secretary for the Board of Trustees.

(d) Any vacancy arising on account of death resignation refusal to act or by any other reason shall be filled up by the remaining Trustees by Co-option.

(e) The quorum for any meeting of the Board of Trustees shall be five.

(f) In case of resignation of a Trustee he is entitled to receive all his investments in the Trust or he can nominate his nominee but such nomination should be got approved by the Board.

(g) In the absence of the Chairman at any meeting the Trustees, who may be present, at the meeting may elect a chairman for the meeting from among themselves.

(h) The Trustees shall keep or cause to be kept a minutes book of their proceedings and other books accounts required and shall get them audited yearly.

(i) The Trustees shall be competent to open and maintain bank accounts in the name of the Trust with such bank or banks as they may decide from time to time.

(k) The Trustees shall have powers to appoint regular staff if necessary according to the requirement for managing the working of the Trust. The Board of Trustees shall have the power to frame such rules and regulations for fulfilment of the purposes of the Trust and for carrying out the objects of the Trust or in connection with the meetings and from time to time repeal, amend add, to or alter the same. They will also have the power to widen the scope of the Trust and add subtract or alter or modify the existing objects of the Trust.

(1) If any disputes arise against the board of Trust or against any other party on behalf of the Trust shall be represented by the Chiarmen of the Trust for the purpose pf good interest of the Trust.


(m) This Trust with all the above terms and conditions shall come into effect forth with or by the date fixed by the Board of Trustees.
